Employee Recognition Program

The Lewis Center for Educational Research and the Lewis Center Foundation are implementing the following Employee Recognition Program.

Anniversary and Milestone Recognition

Regular Employee Anniversaries and Milestones are recognized based on "Seniority Date of Hire" into regular employment by <u>calendar</u> year. Ex: In December 2020, Regular Employees hired in 2019 will be recognized for their 1 year anniversary; Regular Employees hired in 2018 will be recognized for their 2 year anniversary, etc. A Regular Employee is defined as an employee in a numbered position with a regularly scheduled number of hours and days that are specifically designated in the organization's budget. This does not include Certificated or Classified Substitutes, ELPAC Testers, Coaches, and other non-regular (variable) hourly positions.

The "Seniority Date of Hire" is <u>cumulative</u> time worked as a Regular Employee. If a Regular Employee has been consistently employed in Regular Employment and has no gaps, the Seniority Date of Hire is their actual date of hire into Regular Employment. If a Regular Employee left Regular Employment for a period of time and returned to Regular Employment, the time in Regular Employment prior to leaving will count towards the "Seniority Date of Hire", and the date will be adjusted accordingly based on the actual number of years and/or months the employee has worked in Regular Employment.

All Regular Employee Anniversaries and Milestones will be recognized in December of each year through a presentation of an LCER Certificate and an anniversary service pin from their supervisor. A special, exclusive celebration will be planned in December for those reaching Milestone years. Milestone Recognition will include a presentation of a Lewis Center Foundation Certificate and the following bonus amounts/gifts supported by the Lewis Center Foundation for as long as the Lewis Center Foundation can support the program. (No LCER, AAE or NSLA funds will be used for this program.)

Employees eligible for a Milestone Recognition Bonus in 2020 will receive their bonus on their November 15th, 2020 regular paycheck. Beginning in January 2021, employees eligible for a Milestone Recognition Bonus will receive their bonus on their regular paycheck on the 15th of the corresponding month of their Seniority Date of Hire. If the employee's Seniority Date of Hire is in July, and they do not receive a paycheck for that month, they will receive their bonus on their August 15th regular paycheck. If an employee is eligible for a Milestone Recognition Bonus within 31 days of their retirement date and provides a minimum of 30 days notice, they will receive their Bonus on their final paycheck. Bonus amounts are subject to applicable taxes and <u>may not be distributed as a separate check</u>.

Milestone Anniversaries will be announced at December All Staff meetings, a list will be included in the December Lewis Center for Educational Research and Lewis Center Foundation Board Packets, and will also be announced on social media.

Retirement Recognition

Regular Employee Retirements are recognized by presentation of a Lewis Center Foundation Certificate and the following gift/celebration amounts supported by the Lewis Center Foundation for as long as the Lewis Center Foundation can support the program. The Lewis Center Foundation requests a minimum of 30 days notice of retirement in order to have the gift/celebration funds available by the retirement date. (No LCER, AAE or NSLA funds will be used for this program.)
