2015/2016 School Year Simple Rules and Regulations

1. Participating High schools: The participating schools have been chosen to participate in *“Spark Perfect Attendance”program*.
2. Student’s grades: 9th, 10th, 11th and 12th grade students are eligible to participate in the 2015--2016 program.
3. Prize: One (1) new Chevrolet Spark will be awarded to an eligible winner
4. Eligibility: Perfect attendance is defined by the schools as the student being present everyday of the academic school. The list of eligible students is provided to Rancho Motor Company by the participating school(s). Rancho Motor Company offers no assistance for determining a student’s eligibility.
5. The program starts on the first day of class of the 2014/2015 school year for each school and on the date determined by the participating school(s).
6. Eligible students **must be present** at Rancho Motor Company in Victorville for the drawing on a date to be announced in order to win, AND if under the age of 18, it is required that the student bring a parent or legal guardian.
 - a. Exceptions can be made if Rancho Motor Company is notified by the school of a school related activity.
7. Any employees of Rancho Motor Company, affiliated entities, or their immediate family members will not be eligible to participate for the car giveaway.
8. After the drawing, the Chevrolet Spark will remain at Rancho Motor Company until the perfect attendance can be verified with the high school. The school determines final eligibility.
9. One winner per student or household per lifetime for Vehicle prize.
10. Winner responsible for any state or federal income tax the IRS may impose. Rancho Motor Company will cover the state sales tax and vehicle purchase fees.

2015/2016 School Year Rules and Regulations

11. Rancho Motor Company will pay local and state sales taxes and DMV purchase fees, for the winner of the 2016 Chevrolet Spark. A 1099 form will be filed with the IRS. Winner will be responsible for any State and/or Federal Income Tax due as determined by the IRS at annual filing time.
12. Before the winning student is able claim the vehicle, proof of age, California automobile insurance and a valid U.S. driver's license will be required by the student, parent or legal guardian.
13. All Rancho Motor Company's signage/wrap must remain on the Chevrolet Spark for one year and must remain unaltered with the exception of the addition of the students name and/or High School if desired.
14. All vehicle maintenance covered under the Chevy Complete Care complimentary maintenance program must be completed at Rancho Motor Company.
15. Winner must allow Rancho Motor Company to use name, pictures and/or likeness in future promotions without compensation.
16. Void where prohibited by law
17. Eligible schools must agree to not participate in any other vehicle giveaway program related to perfect attendance.
