Project Life Impact / NSAA After School Impact Rates: 2014 – 2015

Hours of operation:

After School Program: Dismissal from school to 6:00pm.

-Kindergarten 1:30pm to 6:00pm

-All other grades 2:30pm to 6:00pm (Wednesdays- minimum day 1:30 to 6:00pm).

The rates are as follows:

Daily:

After School Program grades 1st – 8th: \$14.00 Kindergarten After School Program: \$17.00

Weekly: (All 5 days)

After School Program grades 1st – 8th: \$70.00 Kindergarten After School Program: \$85.00

One Hour Kindergarten Older Sibling Program: \$15.00 flat rate fee four (4) days.

Late Pick up fee:

There will be a late fee for students who are picked-up after 6:05pm. The charge will be \$1.00 per minute after 6:05pm, billed upon usage.

ALL PAYMENTS MUST BE PAID IN ADVANCE. PAYMENTS CAN BE MADE WEEKLY, BI-WEEKLY, OR MONTHLY.

(If student does not attend on a scheduled day, payment still applies for that day)

After School Program A.S.I. Program Policies





Attendance Policy:

- 1. Students can attend on scheduled days only.
- 2. If student does not attend school, he/she cannot attend the After School Program for that day.
- 3. If student does not attend on a scheduled day payment still applies for that day.
- 4. Attendance is based on individual payment agreements.

Late Policy:

- 1. Parent or persons responsible for picking up student **cannot** be more than five (5) minutes late. Pick up time is 6:00pm.
- 2. After 6:05 there will be a late fee of \$1.00 per minute. Fee will be added to your payment.
- 3. Parent(s) or persons responsible for pick-up cannot be late more than three (3) times during the school year; after the 3rd time the student will be subject to dismissal from the program.

Application Policy:

- 1. Must attend Norton Space & Aeronautics Academy.
- 2. Must hand in application to After School Program Site Director at NSAA.
- 3. Parent must complete a payment agreement and pay in advance before student can start program.

Disciplinary Policy

- 1. Verbal warning, parent notification.
- 2. Written warning, parent notification.
- 3. Student is subject to possible dismissal from the program.
- 4. If incident is extreme (causing serious bodily harm, of a sexual nature, or blatant disrespect) student may be subject to suspension or possible dismissal from the After School Program regardless of lack of prior verbal or written notification.

Payment Policy:

- 1. All payments must be paid in advance.
- 2. If payment is not paid, student will not be allowed to attend program.
- 3. All payments are made according to individual payment agreement.
- 4. Payments can be made weekly, by-weekly, or monthly to *Project Life Impact*.
- 5. Cash payments must be the exact amount; otherwise a credit will be given for the next payment due. There will be no change given.

Sign-out Policy:

- 1. All students must be signed out.
- 2. Only approved persons can sign out a student.
- 3. Approved persons must be 18 years or older, and identified on the Student Enrollment Application.

Change or End Contract Policy:

- 1. All changes must be submitted in writing one (1) week in advance.
- 2. Changes to contract will **NOT** take effect until the following week.
- 3. There will only be four (4) changes allowed in payment agreement per school year.
- 4. It is the parent's/guardian's responsibility to submit a notice **in writing** one (1) week in advance to end payment agreement. Otherwise parents will still be charged weekly payments even if the student does not attend program.
